

1 Q. Detective, you've spoken with Jessica Adam on a  
2 number of occasions, correct?

3 A. Yes.

4 Q. And you've spoken to her about the plans that she  
5 has claimed to have had with Ms. Cooper.

6 A. Yes.

7 Q. Do you recall, on July 12th, that she told you that  
8 she had made those plans on the telephone with Nancy at 5  
9 p.m. on Friday afternoon?

10 A. You are continuing on July 12th?

11 Q. Yes, sir. When you spoke with Ms. Adam at 5:30  
12 p.m. If your copy is Bates stamped, I believe it would be  
13 929.

14 A. Yes. I spoke with Ms. Adam at 5:30 p.m., and Ms.  
15 Adam informed me that she spoke with Nancy on July 11th  
16 around 5 p.m.

17 Q. She says that she spoke to her via telephone at 5  
18 p.m.

19 A. Yes.

20 Q. On July 15th, you speak with Ms. Adam again, and  
21 again Ms. Adam tells you that she makes the plans with Nancy  
22 to paint, and that she makes those plans over the telephone.  
23 Is that correct?

24 A. (Reviewing documents.) Yes. Ms. Adam told us that  
25 she spoke to Nancy by telephone at 5 p.m. on Friday, July

1 11th.

2 Q. And then there came a time on July 18th when you  
3 spoke with Ms. Adam. Do you recall that?

4 A. (Reviewing documents.) Yes.

5 Q. And on July 18th -- I'm sorry. If I could actually  
6 direct you to July 22nd. You had spoken to Ms. Adam -- I  
7 believe the Bates stamp would be 8669 if your copy is Bates  
8 stamped.

9 A. I've got the interview that occurred July 22nd.

10 Q. And at that time, Jessica stated that she was at  
11 Nancy's house when she made plans to paint. Isn't that  
12 correct?

13 A. Yes. Ms. Adam clarified that she was at Nancy  
14 Cooper's house on July 11th.

15 Q. When you say "clarified," it's actually a different  
16 version of events. The first two are by telephone; the third  
17 is in person, correct?

18 A. Yes. That is correct. She said that she had  
19 recalled talking with Nancy on the phone but that she was, in  
20 fact, actually at the Cooper house on July 11th as opposed to  
21 talking with her by phone.

22 Q. And then you also understand that Carey Clark was  
23 aware of Nancy's plans to paint.

24 A. Yes.

25 Q. And your understanding from Ms. Clark is that it

1 was at 5:20 a.m. on Friday, before the plans were ever  
2 actually even made, that Ms. Clark was told that she had  
3 plans to paint on Saturday morning?

4 A. (Reviews documents.) Yes. That's what Ms. Clark  
5 stated in her interview.

6 Q. And when was that?

7 A. That was on July 11th that she had the conversation  
8 with Nancy.

9 Q. When was it that she told you that?

10 A. When the date was when she told me that?

11 Q. Yes, sir.

12 A. August 2nd.

13 Q. You also recall you spoke with her on July 12th,  
14 don't you?

15 A. Yes.

16 Q. And on July 12th she never mentioned any knowledge  
17 of Nancy having plans to paint on Saturday?

18 A. No. I spoke with Ms. Clark briefly, and that was a  
19 short interview that day.
